AWARD CRITERIA

- Chamber members and non-members are invited to submit nominations
- Business awards nominees must be Peace River & District Chamber of Commerce members
- Not-for-profit or charitable groups, private institutions and other not-for-profit businesses are considered on the same basis as for-profit businesses
- 2017 Chamber Board Members are not eligible for awards

CATEGORIES FOR NOMINATION:

BUSINESS OF THE YEAR AWARD

The Business of the Year Award is presented to a business of any size, who has demonstrated significant business achievement and sustained financial growth and performance. This business must have demonstrated service excellence, involvement in the community, innovation and a commitment to sustainability.

COMMUNITY INVOLVEMENT AWARD

The Community Involvement Award is presented to a business whose owners or employees are involved in community groups (charitable, not-for-profit, business or professional associations), whose community work or initiatives have improved life for their fellow citizens.

INDUSTRY LEADERSHIP AWARD

The Industry Leadership Award is presented to a business that has contributed to the betterment of the oil and gas industry in Peace River and its district. This business must have 50% of its income come from within the oil and gas industry.

CUSTOMER SERVICE EXCELLENCE AWARD

The Customer Service Excellence Award is presented to a business that has demonstrated excellence within the service industry. This business has a strong dedication to customer satisfaction, customer service or development of an outstanding product, and consistently goes beyond standard customer service practices.

PRESIDENT'S DIAMOND AWARD

In celebration of the Chamber's 100th Diamond Anniversary, The President's Diamond Award is presented to a business that has been a member in good-standing for several decades (20+ years). This business must be originally or generationally-owned and operated. The recipient of this prestigious award is known for their outstanding service, success in business and continued commitment to the betterment of the community.
